

**SUBSTITUTE FOR  
SENATE BILL NO. 680**

A bill to amend 1994 PA 451, entitled  
"Natural resources and environmental protection act,"  
by amending section 30111b (MCL 324.30111b), as added by 2012 PA  
56.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 30111b. (1) A public road end shall not be used for any  
2 of the following unless a recorded deed, recorded easement, or  
3 other recorded dedication expressly provides otherwise:

4           (a) Construction, installation, maintenance, or use of boat  
5 hoists or boat anchorage devices.

6           (b) Mooring or docking of a vessel between 12 midnight and  
7 sunrise.

8           (c) Any activity that obstructs ingress to or egress from the  
9 inland lake or stream.

10           (2) A public road end shall not be used for the construction,

1 installation, maintenance, or use of a dock or wharf other than a  
 2 single seasonal public dock or wharf that is authorized by the  
 3 local unit of government, subject to any permit required under this  
 4 part. This subsection does not prohibit any use that is expressly  
 5 authorized by a recorded deed, recorded easement, or other recorded  
 6 dedication. This subsection does not permit any use that exceeds  
 7 the uses authorized by a recorded deed, recorded easement, other  
 8 recorded dedication, or a court order.

9 (3) ~~The A~~ local unit of government may prohibit a use of a  
 10 public road end **IF** that **USE** violates this section.

11 (4) A person who violates subsection (1) or (2) is guilty of a  
 12 misdemeanor punishable by a fine of not more than \$500.00. Each 24-  
 13 hour period in which a violation exists ~~constitutes~~ **REPRESENTS** a  
 14 separate violation of this section. A peace officer may issue an  
 15 appearance ticket as authorized by sections 9c to 9g of chapter IV  
 16 of the code of criminal procedure, 1927 PA 175, MCL 764.9c to  
 17 764.9g, to a person who violates subsection (1) or (2).

18 (5) This section does not prohibit a person or agency from  
 19 commencing a civil action for conduct that violates this section.

20 (6) As used in this section:

21 (a) "Local unit of government" means ~~the county, A~~ township,  
 22 city, or village ~~with jurisdiction over a public road.~~ **IN WHICH THE**  
 23 **PUBLIC ROAD END IS LOCATED.**

24 ~~— (b) "Public road" means a county road or a township, city, or~~  
 25 ~~village street that is open for use by the public.~~

26 **(B)** ~~(e)~~ "Public road end" means the terminus ~~of a public road~~  
 27 at an inland lake or stream **OF A ROAD THAT IS LAWFULLY OPEN FOR USE**
