

SENATE BILL No. 1311

November 29, 1994, Introduced by Senators DILLINGHAM and WELBORN and referred to the Committee on Family Law, Mental Health, and Corrections.

A bill to amend Act No. 270 of the Public Acts of 1992, entitled as amended

"An act to prohibit certain acts pertaining to the assistance of suicide; to provide for the development of legislative recommendations concerning certain issues related to death and dying, including assistance of suicide; to create the Michigan commission on death and dying; to prescribe its membership, powers, and duties; to prescribe penalties; and to repeal certain parts of this act on a specific date,"

as amended, being sections 752.1021 to 752.1027 of the Michigan Compiled Laws, by adding section 8; and to repeal certain parts of the act.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 270 of the Public Acts of 1992, as
- 2 amended, being sections 752.1021 to 752.1027 of the Michigan
- 3 Compiled Laws, is amended by adding section 8 to read as
- 4 follows:

- 1 SEC. 8. (1) A PERSON WHO KNOWS THAT ANOTHER PERSON INTENDS
- 2 TO COMMIT OR ATTEMPT TO COMMIT SUICIDE AND WHO INTENTIONALLY DOES
- 3 EITHER OF THE FOLLOWING IS GUILTY OF CRIMINAL ASSISTANCE TO SUI-
- 4 CIDE, A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4
- 5 YEARS OR BY A FINE OF NOT MORE THAN \$2,000.00, OR BOTH:
- 6 (A) PROVIDES THE PHYSICAL MEANS BY WHICH THE OTHER PERSON
- 7 ATTEMPTS OR COMMITS SUICIDE.
- 8 (B) PARTICIPATES IN A PHYSICAL ACT BY WHICH THE OTHER PERSON
- 9 ATTEMPTS OR COMMITS SUICIDE.
- 10 (2) SUBSECTION (1) DOES NOT APPLY TO WITHHOLDING OR WITH-
- 11 DRAWING MEDICAL TREATMENT.
- 12 (3) SUBSECTION (1) DOES NOT APPLY TO PRESCRIBING, DISPENS-
- 13 ING, OR ADMINISTERING MEDICATIONS OR PROCEDURES IF THE INTENT IS
- 14 TO RELIEVE PAIN OR DISCOMFORT AND NOT TO CAUSE DEATH, EVEN IF THE
- 15 MEDICATION OR PROCEDURE MAY HASTEN OR INCREASE THE RISK OF DEATH.
- 16 Section 2. Section 7 of Act No. 270 of the Public Acts of
- 17 1992, being section 752.1027 of the Michigan Compiled Laws, is
- 18 repealed.
