

H.B. 6260

A bill to amend 1909 PA 279, entitled  
"The home rule city act,"  
by amending sections 41, 5i, and 35a (MCL 117.41, 117.5i, and  
117.35a), section 41 as amended by 1996 PA 44 and section 5i as  
added by 1994 PA 431.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 41. (1) Consistent with any of the following statutes  
2 and whether or not authorized by the city charter, the legisla-  
3 tive body of a city may adopt an ordinance that designates a vio-  
4 lation of the ordinance as a civil infraction and provides a  
5 civil fine for that violation:

4 (2) Whether or not authorized by the city charter, the leg-  
5 islative body of a city may adopt an ordinance that designates a  
6 violation of the ordinance as a municipal civil infraction and  
7 provides a civil fine for that violation. An ordinance may not  
8 designate a violation as a municipal civil infraction if that  
9 violation may be designated as a civil infraction under  
10 subsection (1). A statute may provide that a violation of a spe-  
11 cific type of ordinance is a municipal civil infraction whether  
12 or not the ordinance designates the violation as a municipal  
13 civil infraction.

14 (3) An ordinance shall not make an act or omission a munici-  
15 pal civil infraction if that act or omission constitutes a crime  
16 under any of the following:

27 punishable by imprisonment for more than 90 days.

[Sec. 5i. (1) Whether or not authorized by its charter, a city with a population of more than ~~1,000,000~~ 750,000 may provide by ordinance a procedure to finance by special assessments the provision by private contractors of snow removal from streets, mosquito abatement, and security services. The ordinance shall authorize the use of petitions to initiate the establishment of a special assessment district. The record owners of not less than 51% of the land comprising the actual special assessment district must have signed the petitions.]

(2) A service instituted under this section may be discontinued upon petition by the record owners of 51% of the land comprising the special assessment district.

Sec. 35a. Any municipality now or hereafter having a population of ~~one million~~ 750,000 or more may issue general obligation bonds and other evidences of debt for all lawful purposes in accordance with the provisions of state law, but subject to the overall debt limitations provided by state law or charter of any such city. No charter shall allocate the debt limitation or any part thereof to specific purposes.]
