February 12, 2002, Introduced by Rep. Julian and referred to the Committee on Tax Policy.

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending section 4504 (MCL 324.4504), as added by 1995 PA 60.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:
