PART 2

PROVISIONS CONCERNING APPROPRIATIONS

GENERAL SECTIONS

21 Sec. 201. Pursuant to section 30 of article IX of the state
 22 constitution of 1963, total state spending from state resources
 23 under part 1 for fiscal year 2010-2011 is \$60,876,500.00 and state
 24 spending from state resources to be paid to local units of
 25 government for fiscal year 2010-2011 is \$1,500,000.00. The itemized

1 statement below identifies appropriations from which spending to
2 local units of government will occur:

6 Sec. 202. The appropriations authorized under this act are
7 subject to the management and budget act, 1984 PA 431, MCL 18.1101
8 to 18.1594.

9 Sec. 203. As used in this act:

- 10 (a) "Department" means the department of agriculture.
- 11 (b) "Director" means the director of the department.
- 12 (c) "EPA" means the United States environmental protection
13 agency.
- 14 (d) "FTE" means full-time equated.
- 15 (e) "HHS-FDA" means the United States department of health and
16 human services - food and drug administration.
- 17 (f) "IDG" means interdepartmental grant.
- 18 (g) "MDELEG" means the Michigan department of energy, labor,
19 and economic growth.
- 20 (h) "MDNRE" means the Michigan department of natural resources
21 and environment.
- 22 (i) "USDA" means the United States department of agriculture.

23 Sec. 204. The civil service commission shall bill departments
24 and agencies at the end of the first fiscal quarter for the charges
25 authorized by section 5 of article XI of the state constitution of
26 1963. Payments shall be made for the total amount of the billing by
27 the end of the second fiscal quarter.

1 Sec. 205. (1) A hiring freeze is imposed on the state
2 classified civil service. State departments and agencies are
3 prohibited from hiring any new full-time state classified civil
4 service employees and prohibited from filling any vacant state
5 classified civil service positions. This hiring freeze does not
6 apply to internal transfers of classified employees from 1 position
7 to another within a department.

8 (2) The state budget director may grant exceptions to this
9 hiring freeze when the state budget director believes that the
10 hiring freeze will result in rendering a state department or agency
11 unable to deliver basic services, causes loss of revenue to the
12 state, would result in the inability of the state to receive
13 federal funds, or would necessitate additional expenditures that
14 exceed any savings from maintaining a vacancy. The state budget
15 director shall report quarterly to the chairpersons of the senate
16 and house standing committees on appropriations the number of
17 exceptions to the hiring freeze approved during the previous
18 quarter and the reasons to justify the exception.

19 Sec. 208. Unless otherwise specified, the department shall use
20 the Internet to fulfill the reporting requirements of this act.
21 This requirement shall include transmission of reports via
22 electronic mail to the recipients identified for each reporting
23 requirement and shall include placement of reports on an Internet
24 or Intranet site.

25 Sec. 209. Funds appropriated in part 1 shall not be used for
26 the purchase of foreign goods or services, or both, if
27 competitively priced and of comparable quality American goods or

1 services, or both, are available. Preference shall be given to
2 goods or services, or both, manufactured or provided by Michigan
3 businesses, if they are competitively priced and of comparable
4 quality. In addition, preference shall be given to goods or
5 services, or both, that are manufactured or provided by Michigan
6 businesses owned and operated by veterans, if they are
7 competitively priced and of comparable quality.

8 Sec. 210. The director shall take all reasonable steps to
9 ensure businesses in deprived and depressed communities compete for
10 and perform contracts to provide services or supplies, or both. The
11 director shall strongly encourage firms with which the department
12 contracts to subcontract with certified businesses in depressed and
13 deprived communities for services, supplies, or both.

14 Sec. 212. (1) Of the funds appropriated in part 1, the
15 department may provide for indemnity as provided for pursuant to
16 the animal industry act, 1988 PA 466, MCL 287.701 to 287.746, not
17 to exceed \$100,000.00 per order from any line item for the fiscal
18 year ending September 30, 2011. Before the department provides for
19 an indemnification under this section, the department shall report
20 the reason for the indemnification, the amount of the
21 indemnification, and to whom the indemnification is to be paid. The
22 report shall be given to each member of the senate and house
23 appropriations subcommittees on agriculture and to the senate and
24 house fiscal agencies and the state budget director.

25 (2) The department of agriculture shall make an
26 indemnification payment for the fair market value of livestock
27 killed by a wolf, coyote, or cougar, if the kill is verified by the

1 department of natural resources and environment. The fair market
2 value of the livestock shall be determined pursuant to the
3 indemnification procedures prescribed in the animal industry act,
4 1988 PA 466, MCL 287.701 to 287.745. In addition to the funds
5 appropriated in part 1, the department of agriculture is authorized
6 to expend the funds received from the department of natural
7 resources and environment to reimburse the department of
8 agriculture for all indemnification payments made pursuant to this
9 subsection.

10 Sec. 214. Of the funds appropriated in part 1 that are other
11 than line-item grants, the department shall not provide grants to
12 local government agencies, institutions of higher education, or
13 nonprofit organizations unless the department provides notice of
14 the grant to the senate and house appropriations subcommittees on
15 agriculture at least 10 days before the grant is issued. The grants
16 shall be used to support research or other related activities for
17 the purpose of enhancing the agricultural industries in this state.

18 Sec. 215. From the funds appropriated in part 1, the
19 department shall use an amount not to exceed \$10,000.00 to develop,
20 post, and maintain, on a publicly accessible Internet site, all
21 expenditures made by the agency within a fiscal year. The posting
22 must include the purpose for which each expenditure is made. The
23 department shall not be required to hire additional employees to
24 comply with this section.

25 Sec. 219. From the funds appropriated in part 1 for
26 information technology, departments and agencies shall pay user
27 fees to the department of technology, management, and budget for

1 technology-related services and projects. The user fees shall be
2 subject to provisions of an interagency agreement between the
3 department and the department of technology, management, and
4 budget.

5 Sec. 220. Amounts appropriated in part 1 for information
6 technology may be designated as work projects and carried forward
7 to support technology projects under the direction of the
8 department of technology, management, and budget. Funds designated
9 in this manner are not available for expenditure until approved as
10 work projects under section 451a of the management and budget act,
11 1984 PA 431, MCL 18.1451a.

12 Sec. 223. (1) Due to the current budgetary problems in this
13 state, out-of-state travel shall be limited to situations in which
14 1 or more of the following conditions apply:

15 (a) The travel is required by legal mandate or court order or
16 for law enforcement purposes.

17 (b) The travel is necessary to protect the health or safety of
18 Michigan citizens or visitors or to assist other states in similar
19 circumstances.

20 (c) The travel is necessary to produce budgetary savings or to
21 increase state revenues, including protecting existing federal
22 funds or securing additional federal funds.

23 (d) The travel is necessary to comply with federal
24 requirements.

25 (e) The travel is necessary to secure specialized training for
26 staff that is not available within this state.

27 (f) The travel is financed entirely by federal or nonstate

1 funds.

2 (2) Not later than January 1 of each year, each department
3 shall prepare a travel report listing all travel by classified and
4 unclassified employees outside this state in the immediately
5 preceding fiscal year that was funded in whole or in part with
6 funds appropriated in the department's budget. The report shall be
7 submitted to the senate and house appropriations committees, the
8 senate and house fiscal agencies, and the state budget director.
9 The report shall include the following information:

10 (a) The name of each person receiving reimbursement for travel
11 outside this state or whose travel costs were paid by this state.

12 (b) The destination of each travel occurrence.

13 (c) The dates of each travel occurrence.

14 (d) A brief statement of the reason for each travel
15 occurrence.

16 (e) The transportation and related costs of each travel
17 occurrence, including the proportion funded with state general
18 fund/general purpose revenues, the proportion funded with state
19 restricted revenues, the proportion funded with federal revenues,
20 and the proportion funded with other revenues.

21 (f) A total of all out-of-state travel funded for the
22 immediately preceding fiscal year.

23 Sec. 224. The department shall not take disciplinary action
24 against an employee for truthfully to the best of his or her
25 knowledge communicating with a member of the legislature or his or
26 her staff.

27 Sec. 228. (1) In addition to the funds appropriated in part 1,

1 there is appropriated an amount not to exceed \$5,000,000.00 for
2 federal contingency funds. These funds are not available for
3 expenditure until they have been transferred to another line item
4 in this act under section 393(2) of the management and budget act,
5 1984 PA 431, MCL 18.1393.

6 (2) In addition to the funds appropriated in part 1, there is
7 appropriated an amount not to exceed \$6,000,000.00 for state
8 restricted contingency funds. These funds are not available for
9 expenditure until they have been transferred to another line item
10 in this act under section 393(2) of the management and budget act,
11 1984 PA 431, MCL 18.1393.

12 (3) In addition to the funds appropriated in part 1, there is
13 appropriated an amount not to exceed \$100,000.00 for local
14 contingency funds. These funds are not available for expenditure
15 until they have been transferred to another line item in this act
16 under section 393(2) of the management and budget act, 1984 PA 431,
17 MCL 18.1393.

18 (4) In addition to the funds appropriated in part 1, there is
19 appropriated an amount not to exceed \$100,000.00 for private
20 contingency funds. These funds are not available for expenditure
21 until they have been transferred to another line item in this act
22 under section 393(2) of the management and budget act, 1984 PA 431,
23 MCL 18.1393.

24 Sec. 229. (1) The department shall report no later than April
25 1, 2011 on each specific policy change made to implement a public
26 act affecting the department that took effect during the prior
27 calendar year to the senate and house appropriations subcommittees

1 on the budget for the department, the joint committee on
2 administrative rules, and the senate and house fiscal agencies.

3 (2) Funds appropriated in part 1 shall not be used by the
4 department to adopt a rule that will apply to a small business and
5 that will have a disproportionate economic impact on small
6 businesses because of the size of those businesses if the
7 department fails to reduce the disproportionate economic impact of
8 the rule on small businesses as provided under section 40 of the
9 administrative procedures act of 1969, 1969 PA 306, MCL 24.240.

10 (3) As used in this section:

11 (a) "Rule" means that term as defined under section 7 of the
12 administrative procedures act of 1969, 1969 PA 306, MCL 24.207.

13 (b) "Small business" means that term as defined under section
14 7a of the administrative procedures act of 1969, 1969 PA 306, MCL
15 24.207a.

16 Sec. 230. Funds appropriated in part 1 shall not be used by a
17 principal executive department, state agency, or authority to hire
18 a person to provide legal services that are the responsibility of
19 the attorney general. This prohibition does not apply to legal
20 services for bonding activities and for those activities that the
21 attorney general authorizes.

22 Sec. 231. From the funds appropriated in part 1 for salaries
23 and benefits, the department shall provide funding in the pesticide
24 and plant pest management, food and dairy, animal industry,
25 environmental stewardship and laboratory divisions for not less
26 than 315 employees who provide direct service to the public or
27 substantially support the work of those who provide direct service.

1 Expenditures shall be made so that these divisions continue to
2 provide service to protect the public health, safety, and welfare
3 and environment.

4 Sec. 237. Not later than September 30, 2011, the department
5 shall prepare and transmit a report that provides for estimates of
6 the total general fund/general purpose appropriation lapses at the
7 close of the fiscal year. This report shall summarize the projected
8 year-end general fund/general purpose appropriation lapses by major
9 departmental program or program areas. The report shall be
10 transmitted to the office of the state budget, the chairpersons of
11 the senate and house appropriations committees, and the senate and
12 house fiscal agencies.

13 EXECUTIVE

14 Sec. 302. (1) Pursuant to the appropriations in part 1, the
15 department may receive and expend revenue and use that revenue to
16 cover necessary expenses related to publications, audit and
17 licensing functions, livestock sales, certification of nursery
18 stock, and laboratory analyses as specified in the following:

19 (a) Management services publications.

20 (b) Management services audit and licensing functions.

21 (c) Pesticide and plant pest management propagation and
22 certification of virus-free foundation stock.

23 (d) Pesticide and plant pest management grading services.

24 (e) Laboratory support testing for testing horses in draft
25 horse pulling contests at county fairs when local jurisdictions
26 request state assistance.

1 (f) Laboratory support analyses to determine foreign
2 substances in horses engaged in racing or pulling contests at
3 tracks.

4 (g) Laboratory support analyses of food, livestock, and
5 agricultural products for disease, foreign products for disease,
6 toxic materials, foreign substances, and quality standards.

7 (h) Laboratory support test samples for other agencies and
8 organizations.

9 (i) Fruit and vegetable inspection at shipping and termination
10 points and processing plants.

11 (2) The department shall notify the senate and house
12 appropriations subcommittees on agriculture and the senate and
13 house fiscal agencies 30 days prior to proposing changes in fees
14 authorized under this section or under section 5 of 1915 PA 91, MCL
15 285.35.

16 (3) Annually, before February 1, the department shall provide
17 a report to the senate and house appropriations subcommittees on
18 agriculture and the senate and house fiscal agencies detailing all
19 the fees charged by the department under the authorization provided
20 in this section, including, but not limited to, rates, number of
21 individuals paying each fee, and the revenue generated by each fee
22 in the previous fiscal year.

23 Sec. 306. From the funds appropriated in section 102, private
24 funds for agricultural statistics shall be used to match state
25 funds at not less than 50% of study costs.

26 **FOOD AND DAIRY**

1 Sec. 401. The department shall monitor restaurant inspection
2 and licensing functions carried out by local health departments to
3 ensure uniform application and enforcement of minimum program
4 requirements.

5 Sec. 402. Not later than April 1, 2011, the department shall
6 provide a report to the senate and house appropriations
7 subcommittees on agriculture and the senate and house fiscal
8 agencies describing significant food-borne outbreaks and
9 emergencies, including any enforcement actions taken related to
10 food safety during the 2009-2010 fiscal year.

11 Sec. 404. From the funds appropriated in section 104 for food
12 safety and quality assurance, not less than \$150,000.00 from the
13 consumer and industry food safety education fund shall be expended
14 for purposes required under section 4117 of the food law of 2000,
15 2000 PA 92, MCL 289.4117, including the statewide training and
16 education to consumers on food safety and the training and
17 education on food safety to food service establishment employees
18 and department employees and agents who enforce section 4117 of the
19 food law of 2000, 2000 PA 92, MCL 289.4117.

20 Sec. 406. Notwithstanding the provisions of section 205, the
21 department is authorized to fill open positions in the food and
22 dairy inspection program.

23 **ANIMAL INDUSTRY**

24 Sec. 450. From the funds appropriated in section 105 for the
25 bovine tuberculosis program, the department shall reimburse the
26 department of natural resources and environment for those costs

1 associated with monitoring and testing wildlife for bovine
2 tuberculosis that are necessary to support the department goals and
3 are jointly agreed to by the department and the department of
4 natural resources and environment to be in excess of efforts
5 necessary to effectively plan and execute the eradication of bovine
6 tuberculosis from Michigan's wild free-ranging deer herd.

7 Sec. 451. From the funds appropriated in section 105 for
8 bovine tuberculosis, the department shall pay for all whole herd
9 testing costs and individual animal testing costs in the modified
10 accredited zone to maintain split-state status requirements. These
11 costs include indemnity and compensation for injury causing death
12 or downer to animals.

13 Sec. 452. The department shall apply for all federal and
14 private funds for which it is eligible that can be used to support
15 the bovine tuberculosis program.

16 Sec. 454. The department shall use its resources to
17 collaborate with the United States department of agriculture to
18 obtain TB-free status for the area of the Lower Peninsula that is
19 zoned as modified accredited advanced. The department shall also
20 aggressively work toward eradicating bovine TB in the modified
21 accredited zone.

22 Sec. 456. Of the funds appropriated in part 1, no funds shall
23 be used to enforce the mandatory electronic animal identification
24 program for any domestic animals other than cattle until specific
25 procedures and guidelines for electronic animal identification are
26 outlined in statute.

27 Sec. 457. On or before October 15, 2010, and on a quarterly

1 basis thereafter, the department shall report to the senate and
2 house agriculture committees, the senate and house appropriations
3 subcommittees on agriculture, and the senate and house fiscal
4 agencies on the department's progress toward meeting the USDA
5 requirements as outlined in the March 2007 bovine TB program
6 review. The report shall include, but is not limited to,
7 information and data on: wildlife risk mitigation plan
8 implementation in the modified accredited zone; implementation of a
9 movement certificate process; progress toward annual surveillance
10 test requirements set out in the June 2007 MOU; compliance efforts
11 and rates for animals crossing the Mackinac Bridge; efforts to work
12 with slaughter facilities in Michigan, as well as those that
13 slaughter a significant number of animals from Michigan;
14 educational programs and information for Michigan's livestock
15 community; any other item the legislature should be aware of that
16 will promote or hinder efforts to achieve bovine TB-free status for
17 Michigan.

18 Sec. 458. From the funds appropriated in section 105 for
19 animal industry, the department shall provide inspection and
20 testing of aquaculture facilities and aquaculture researchers as
21 provided under the Michigan aquaculture development act, 1996 PA
22 199, MCL 286.877. It is the intent of the legislature that the
23 department shall work with aquaculture facilities and aquaculture
24 researchers to identify, contain, and eradicate viral hemorrhagic
25 septicemia in this state.

26 Sec. 459. Notwithstanding the provisions of section 205, the
27 department is authorized to fill open positions in the bovine

1 tuberculosis program.

2 Sec. 460. Of the appropriation in section 105 for animal
3 health and welfare, budgetary reductions for the fiscal year ending
4 September 30, 2011 shall not be taken from the aquaculture program,
5 but shall be taken from other programs funded in the animal health
6 and welfare appropriation line item.

7 **PESTICIDE AND PLANT PEST MANAGEMENT**

8 Sec. 551. It is the intent of the legislature that the
9 department work with the fruit and vegetable industry to ensure the
10 development of a sustainable system of third-party inspections of
11 fruits and vegetables.

12 Sec. 552. The department shall evaluate methods for limiting
13 the transport of invasive species in or on pallets. The evaluation
14 shall include an assessment for the costs and benefits of using
15 commercially available treatments for mitigating infestation and
16 preventing reinfestation of pallets. The department shall report to
17 the legislature on the findings of the evaluations and make
18 recommendations for limiting the transport of invasive species in
19 pallets.

20 Sec. 553. From the funds appropriated in part 1 for pesticide
21 and plant pest management, not less than \$200,000.00 shall be used
22 for the purpose to ensure that Michigan commodities receive
23 departmental inspections required by other governments to ship
24 commodities out of Michigan. The department shall devise a plan to
25 provide these required government inspections in a timely manner.

1 **ENVIRONMENTAL STEWARDSHIP**

2 Sec. 603. The department shall apply for all federal funds for
3 which it is eligible that can be used to support the migrant labor
4 housing program.

5 Sec. 606. The department shall actively search for all
6 possible funding sources to be used to match federal funds in the
7 USDA environmental quality incentives program.

8 Sec. 607. It is the intent of the legislature that the
9 department continue its activities in support of intercounty
10 drainage districts as provided in chapter 5 of the drain code of
11 1956, 1956 PA 40, MCL 280.101 to 280.106.

12 **AGRICULTURE DEVELOPMENT**

13 Sec. 706. Not later than April 1, 2011, the department shall
14 provide a report to the senate and house appropriations
15 subcommittees on agriculture and the senate and house fiscal
16 agencies describing the department's agriculture development and
17 export market development activities. The report shall identify
18 grants awarded during the prior fiscal year, including a
19 description of federal or private funds made available as a result
20 of department activities.

21 Sec. 709. (1) Not later than April 1, 2011, the department
22 shall provide a report to the senate and house appropriations
23 subcommittees on agriculture and the senate and house fiscal
24 agencies describing the activities of the grape and wine industry
25 council established under section 303 of the Michigan liquor
26 control act of 1998, 1998 PA 58, MCL 436.1303.

1 (2) The report shall include all of the following:

2 (a) Council activities and accomplishments for the previous
3 fiscal year.

4 (b) Council expenditures for the previous fiscal year by
5 category of administration, industry support, research and
6 education grants, and promotion and consumer education.

7 (c) Grants awarded during the prior fiscal year and the
8 results of research grant projects completed during the prior
9 fiscal year.

10 Sec. 711. In accordance with chapter 8B of the Michigan
11 strategic fund act, 1984 PA 270, MCL 125.2089 to 125.2089d, it is
12 the intent of the legislature that the Michigan strategic fund, its
13 employees, contract employees, and individuals working on its
14 behalf collaborate with the Michigan department of agriculture to
15 promote business development of Michigan agricultural products to
16 achieve outcomes that include, but are not limited to, increases in
17 export sales, increases in the number of retailers carrying
18 Michigan commodities both within and outside of this state, and
19 increased sales of Michigan products at chain grocers.

20 **FAIRS AND EXPOSITIONS**

21 Sec. 801. All appropriations from the agricultural equine
22 industry development fund shall be spent on equine related
23 purposes. No funds from the agriculture equine industry development
24 fund shall be expended for nonequine related purposes without prior
25 approval of the legislature.

26 Sec. 802. All appropriations from the agricultural equine

1 industry development fund shall be reduced proportionately if
2 revenues to the agricultural equine industry development fund
3 decline during the fiscal year ending September 30, 2011 to a level
4 lower than the amount appropriated in part 1.

5 Sec. 803. In the event there is no live thoroughbred race meet
6 in 2010 or 2011, all purse money and program money appropriated for
7 the thoroughbred industry in fiscal year 2009-2010 and fiscal year
8 2010-2011 shall be held in escrow for a period not to exceed 18
9 months, or until a thoroughbred race meet license is applied for
10 and granted by the Michigan gaming control board. In the event
11 there is no thoroughbred meet in 2010 or 2011, the purse pool
12 distribution order to be issued by the Michigan gaming control
13 board in 2011 that delineates distribution between the thoroughbred
14 meet that has been held at pinnacle race course and the joint
15 thoroughbred/quarterhorse meet held in Mt. Pleasant shall be the
16 same distribution formula as issued in 2010, with the thoroughbred
17 portion being held in escrow.

18 CAPITAL OUTLAY

19 Sec. 1001. Of the amounts appropriated in part 1 for farmland
20 and open space development acquisition, the funds shall be used for
21 the purchase of development rights and the awarding of grants by
22 the agriculture preservation fund board under the natural resources
23 and environmental protection act, 1994 PA 451, MCL 324.101 to
24 324.90106.

25 Sec. 1002. (1) The director shall allocate lump-sum
26 appropriations made in this act consistent with statutory

1 provisions and the purposes for which funds were appropriated.
2 Lump-sum allocations shall address priority program or facility
3 needs and may include, but are not limited to, design,
4 construction, remodeling and addition, special maintenance, major
5 special maintenance, energy conservation, and demolition.

6 (2) The state budget director may authorize that funds
7 appropriated for lump-sum appropriations shall be available for no
8 more than 3 fiscal years following the fiscal year in which the
9 original appropriation was made. Any remaining balance from
10 allocations made in this section shall lapse to the fund from which
11 it was appropriated pursuant to the lapsing of funds as provided in
12 the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

13 Sec. 1003. The appropriations in part 1 for capital outlay
14 shall be carried forward at the end of the fiscal year consistent
15 with the provisions of section 248 of the management and budget
16 act, 1984 PA 431, MCL 18.1248.
