Dr. Ryan Beilfuss of First Baptist Church of Evart offered the following invocation:

Senator Anderson asked and was granted unanimous consent to make a statement and moved that the statement be printed in the Journal.

Senator Anderson's statement is as follows:

I rise this morning to ask my colleagues in the Michigan Senate to join me in honoring a fallen police officer from my district. Officer Larry Nehasil was shot and killed on Monday, January 18, during an exchange of gunfire with a suspect in a home invasion in Walled Lake.

Officer Larry Nehasil was an exceptional and dedicated police officer, having received two chief of police awards, five commendations, one unit commendation, and a Livonia Police Department award in 1995. Officer Larry Nehasil is survived by his wife Linda, two sons Adam and Aaron, two sisters, and a brother.

His death is a terrible loss for law enforcement, the Livonia community, and, indeed, our state. I ask that the Michigan Senate observe a moment of silence to honor his memory.

A moment of silence was observed in memory of Officer Larry Nehasil.

A resolution proclaiming February 3, 2011, as Go Red for Women Day.

Whereas, Heart disease is the No. 1 cause of death among women; and

Whereas, Cardiovascular disease claims the lives of 460,000 American women every year—almost one death per minute—and only 1 in 3 women can properly identify the symptoms of a heart attack; and

Whereas, More women die of cardiovascular disease than the next five causes of death combined, including all forms of cancer; and

Whereas, Sixty-four percent of women who die suddenly of coronary heart disease have no previous symptoms and in 2006, females represented 52.1 percent of deaths from cardiovascular disease; and

Whereas, Research shows that 80 percent of cardiac events in women could be prevented if women made the right choices for their hearts and were made aware of the symptoms associated with heart attacks; and

Whereas, The American Heart Association started Go Red for Women Day in 2004 to educate women about heart disease and its prevention; and

Whereas, Go Red for Women Day is celebrated throughout the United States to raise awareness of heart disease in women and how to prevent it; now, therefore, be it

Resolved by the Senate, That in recognition of the importance of the ongoing fight against heart disease and stroke, we do hereby proclaim February 3, 2011, as Go Red for Women Day in Michigan. We encourage all citizens to wear red in recognition of family, friends, and neighbors who have suffered from heart disease and as a show of support to fight this deadly disease. By increasing awareness of the risk factors for this devastating disease and taking actions to reduce them, we can save thousands of lives each year; and be it further

Resolved, That a copy of this resolution be transmitted to the Go Red for Women Leadership Committee as evidence of our esteem for their dedication and commitment to fighting this disease and saving countless lives.

I rise in the chamber with my fellow colleagues in support of a resolution for Go Red for Women and the importance of educating Michigan's women on the dangers of heart disease—the No. 1 cause of death among women.

Senator Whitmer's statement is as follows:

In 2004, the American Heart Association faced a challenge. Cardiovascular disease claimed the lives of nearly 500,000 women each year, yet women were not paying attention. This is more than all cancers combined. In fact, many even dismissed it as an older man's disease.

Senator Emmons' statement is as follows:

To dispel the myths and raise awareness of heart disease as the No. 1 killer of woman, the American Heart Association created Go Red for Women, a passionate, emotional, social initiative designed to empower women to take charge of their heart health.

Senator Warren's statement is as follows:

Therefore, the bipartisan Women's Caucus rises today to request your support in proclaiming February 3 as Go Red for Women Day. I would like to remind you to wear red that day while you are on the floor.

Statements

Senator Hunter asked and was granted unanimous consent to make a statement and moved that the statement be printed in the Journal.

The motion prevailed.

Senator Hunter's statement is as follows:

I rise today to speak on an issue that I feel must be a priority for the Senate to address this term, and that is autism spectrum disorder. This is an issue that many of us are deeply concerned about and an issue that saw bipartisan cooperation during the last legislative session. Last December, we came close to passing a bill that would have added Michigan to the long list of states requiring insurance companies to cover autism treatments. I hope that we will continue working on this issue this year with the goal of quickly passing this much-needed legislation.

According to the National Council of State Legislatures, in 2010, eight states have enhanced their existing laws that provide for insurance coverage for autism. Those states are Iowa, Kansas, Kentucky, Maine, Missouri, New Hampshire, Vermont,

and Massachusetts. Twenty-three states have now passed laws that specifically require insurance companies to cover autism treatments. Another nine states provide assistance with the cost of autism treatments in other ways. Georgia, for example, requires that insurers that provide benefits for neurological disorders cannot deny benefits for neurological disorders because of a diagnosis of autism.

In 2010, Oklahoma covered autism treatments by enacting legislation specifying that health insurance policies that provide medical and surgical benefits must provide the same coverage and benefits to children under the age of 18 years who has been diagnosed with an autistic disorder as it would provide coverage to an individual who has not been diagnosed with the disorder. According to the group Autism Speaks, Oregon is the first state to introduce autism insurance legislation in 2011. NCSL also lists Mississippi as another state that has introduced autism insurance legislation this year.

I have introduced autism insurance legislation, and I am hopeful for immediate consideration. This is a bipartisan issue, and I appreciate Senate Majority Leader Richardville's work last year for hosting autism insurance coverage hearings across the state. Michigan families are struggling with the cost of the treatments their children need. We all buy insurance policies to help us with the costs that we otherwise could not afford. Families with autistic children want and need this same option. These families are not asking for a handout. They are just asking for the option to buy health insurance to help with the costs of the treatments their children need in order to reach their full potential.
