

**SUBSTITUTE FOR
HOUSE BILL NO. 5641**

A bill to amend 1961 PA 236, entitled
"Revised judicature act of 1961,"
(MCL 600.101 to 600.9947) by adding section 2950n.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 **SEC. 2950N. (1) IN AN ACTION DESCRIBED IN SECTION 2950(1) OR**
2 **2950A(1), OR IN ANOTHER ACTION IF THE RESPONDENT IN THE ACTION HAS**
3 **BEEN ORDERED, IN A SEPARATE CRIMINAL CASE, TO HAVE NO CONTACT WITH**
4 **THE PETITIONER OR A MINOR CHILD OF WHOM THE PETITIONER HAS LEGAL**
5 **CUSTODY, THE COURT MAY ENTER AN ORDER TO ALLOW THE PETITIONER TO**
6 **MAINTAIN AN EXISTING WIRELESS TELEPHONE NUMBER, OR THE WIRELESS**
7 **TELEPHONE NUMBER OF A MINOR CHILD OF WHOM THE PETITIONER HAS LEGAL**
8 **CUSTODY, IF THE PETITIONER IS NOT THE NAMED CUSTOMER, BY ORDERING**
9 **THE WIRELESS TELEPHONE SERVICE PROVIDER TO TRANSFER THE BILLING**
10 **RESPONSIBILITY FOR AND RIGHTS TO THE WIRELESS TELEPHONE NUMBER TO**
11 **THE PETITIONER.**

1 (2) AN ORDER ISSUED UNDER SUBSECTION (1) MUST LIST THE NAME
2 AND BILLING TELEPHONE NUMBER OF THE NAMED CUSTOMER, THE NAME AND
3 TELEPHONE NUMBER OF THE PETITIONER, AND EACH TELEPHONE NUMBER TO BE
4 TRANSFERRED TO THE PETITIONER. THE COURT SHALL ENSURE THAT THE
5 CONTACT INFORMATION OF THE PETITIONER IS NOT PROVIDED TO THE
6 CUSTOMER OR RESPONDENT.

7 (3) THIS SECTION AND SECTION 2950○ DO NOT AFFECT THE ABILITY
8 OF THE COURT TO DETERMINE THE TEMPORARY USE, POSSESSION, AND
9 CONTROL OF PERSONAL PROPERTY OR TO APPORTION THE ASSETS AND DEBTS
10 OF THE PARTIES AS OTHERWISE PROVIDED BY LAW.

11 (4) THE STATE COURT ADMINISTRATIVE OFFICE SHALL DEVELOP ANY
12 FORMS NECESSARY TO EFFECTUATE THIS SECTION AND SECTION 2950○.

13 Enacting section 1. This amendatory act takes effect 90 days
14 after the date it is enacted into law.

15 Enacting section 2. This amendatory act does not take effect
16 unless House Bill No. 5642 of the 98th Legislature is enacted into
17 law.
