A bill to amend 1937 PA 72, entitled
"Division on deafness act,"
by amending section 4 (MCL 408.204), as amended by 1988 PA 434.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 4. (1) Under the supervision of the department, the
2 division shall do all of the following:

3 (a) Advocate for **DEAF, DEAFBLIND, AND HARD OF** hearing ~~impaired~~
4 persons who encounter communication and other difficulties in
5 employment, education, public accommodation, public service, and
6 housing.

7 (b) Work closely with all public and privately funded
8 organizations that provide developmental, educational, financial,
9 preventative, protective, placement, recreational, rehabilitative,
10 or health services to **DEAF, DEAFBLIND, AND HARD OF** hearing ~~impaired~~
11 persons.

1 (c) Encourage providers of services to **DEAF, DEAFBLIND, AND**
2 **HARD OF** hearing ~~impaired~~ persons to improve the quality and
3 coordination of their delivery systems.

4 (d) Provide information on deafness to **DEAF, DEAFBLIND, AND**
5 **HARD OF** hearing ~~impaired~~ persons and the public.

6 (e) Provide information and referral services to **DEAF,**
7 **DEAFBLIND, AND HARD OF** hearing ~~impaired~~ persons to ~~insure~~ **ENSURE**
8 that their rights are protected.

9 (f) Provide information to **DEAF, DEAFBLIND, AND HARD OF**
10 hearing ~~impaired~~ persons on programs and services provided for them
11 by each level of government.

12 (g) Promote new services, when necessary, for **DEAF, DEAFBLIND,**
13 **AND HARD OF** hearing ~~impaired~~ persons.

14 (h) Sponsor or cosponsor conferences, workshops, or seminars
15 to educate **DEAF, DEAFBLIND, AND HARD OF** hearing ~~impaired~~ persons
16 and the public about deafness.

17 (i) Maintain statistics, facts, and data pertaining to **DEAF,**
18 **DEAFBLIND, AND HARD OF** hearing ~~impaired~~ persons of all ages and
19 degrees of hearing loss.

20 (j) Provide technical assistance to state agencies and the
21 public regarding communication accessibility for **DEAF, DEAFBLIND,**
22 **AND HARD OF** hearing ~~impaired~~ persons.

23 (k) ~~Provide direct interpreter services to~~ **COORDINATE WITH**
24 state agencies, the legislature, and the governor **ON REQUESTS FOR**
25 **DIRECT INTERPRETER SERVICES.**

26 (l) Fulfill its duties under the deaf persons' interpreters
27 act, ~~Act No. 204 of the Public Acts of 1982, being sections 393.501~~

1 ~~to 393.509 of the Michigan Compiled Laws.1982 PA 204, MCL 393.501~~
2 **TO 393.509.**

3 (2) The division may assess reasonable fees for conferences
4 sponsored or cosponsored by the division, the use of materials
5 developed by the division, and for services provided by the
6 division.

7 Enacting section 1. This amendatory act takes effect 90 days
8 after the date it is enacted into law.
