October 19, 2016, Introduced by Reps. Cochran, Poleski, Irwin, Hovey-Wright, Lane, Greig, Wittenberg and Darany and referred to the Committee on Agriculture.

A bill to amend 1976 PA 412, entitled

"An act to provide for the suppression of serious diseases among bees; to prescribe certain powers and duties of the director of the department of agriculture; and to repeal certain acts and parts of acts,"

(MCL 286.801 to 286.821) by amending the title, as amended by 1993 PA 108, and by adding section 3.

- 1 (C) INCREASES IN POLLINATOR HABITAT.
- 2 (D) MAINTENANCE OF EXISTING COMPLIANCE WITH STATE PESTICIDE
- 3 USE REQUIREMENTS.
- 4 (E) IDENTIFICATION OF NEEDS FOR FURTHER RESEARCH TO PROMOTE
- 5 ROBUST AGRICULTURE AND APIARY INDUSTRIES.
- 6 (F) IDENTIFICATION OF ADDITIONAL OPPORTUNITIES FOR EDUCATION
- 7 AND OUTREACH ON POLLINATORS.
- 8 (4) BY 1 YEAR AFTER THE EFFECTIVE DATE OF THIS SECTION, THE
- 9 DEPARTMENT SHALL PROVIDE A REPORT ON ITS PROPOSED PLAN TO THE
- 10 SENATE AND HOUSE COMMITTEES ON AGRICULTURE AND ON NATURAL RESOURCES
- 11 AND TO THE GOVERNOR AND SHALL, UPON COMPLETION OF THE PLAN BUT NOT
- 12 LATER THAN 2 YEARS AFTER THE EFFECTIVE DATE OF THIS SECTION, REPORT
- 13 ON THE IMPLEMENTATION OF THE PLAN TO THOSE COMMITTEES AND THE
- 14 GOVERNOR.
- 15 Enacting section 1. This amendatory act takes effect 90 days
- 16 after the date it is enacted into law.
