

HOUSE BILL NO. 6404

November 12, 2020, Introduced by Reps. Meerman and Steven Johnson and referred to the Committee on Government Operations.

A bill to amend 1917 PA 5, entitled

"An act authorizing organized townships and incorporated villages in the state of Michigan to borrow money and to issue bonds therefor for the purpose of establishing free public libraries, purchasing sites and constructing buildings thereon,"

by amending section 2 (MCL 397.322).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 2. The question of issuing ~~the bonds~~ ~~provided for in~~
2 **under** section 1 ~~of this act,~~ ~~shall~~ **must** be submitted to the legal
3 ~~voters~~ **electors** of ~~such a~~ township ~~or~~ incorporated village ~~by~~

1 the township board, the village council, or **the** board of trustees ~~7~~
 2 within 30 days after the ~~filing of the application mentioned in~~ **is**
 3 **filed under** section 1. ~~7, giving due~~ **Before January 1, 2022, the**
 4 **township board, the village council, or the board of trustees shall**
 5 **provide** notice ~~thereof~~ **of the question of issuing bonds under**
 6 **section 1** by ~~causing~~ **posting in writing or print** the date, place of
 7 voting, and object of ~~said~~ **the** election ~~to be stated in written or~~
 8 ~~printed notices to be posted in~~ 5 public places in ~~such~~ **the**
 9 township ~~7~~ or incorporated village ~~7~~ at least 10 days before the
 10 time fixed by ~~said~~ **the** board for ~~such~~ **the** election, and by
 11 publishing the ~~same~~ **notice** in at least 1 newspaper published in
 12 ~~said~~ **the** township ~~7~~ or incorporated village, or if ~~none~~ **be a**
 13 **newspaper is not** published in ~~said~~ **the** township ~~7~~ or incorporated
 14 village, then in ~~some~~ **a** newspaper published in the same county ~~7~~
 15 ~~which is~~ **and** circulated in ~~such~~ **the** township or incorporated
 16 village, at least 2 weeks before the time of ~~such~~ **the** election.
 17 ~~Such~~ **Beginning January 1, 2022, not less than 14 days before the**
 18 **time of the election, the township board, the village council, or**
 19 **the board of trustees shall provide public notice of the question**
 20 **of issuing bonds as set forth in the local government public notice**
 21 **act. The** notice ~~shall~~ **must** state the amount of money proposed to be
 22 raised by ~~such~~ **the** bonding, and the purpose or purposes to which ~~it~~
 23 ~~shall~~ **the money will** be applied.

24 Enacting section 1. This amendatory act does not take effect
 25 unless Senate Bill No. ____ or House Bill No. 6440 (request no.
 26 02449'19) of the 100th Legislature is enacted into law.
