

**SUBSTITUTE FOR  
SENATE BILL NO. 944**

A bill to amend 1976 PA 451, entitled  
"The revised school code,"  
by amending sections 503c, 523c, and 553c (MCL 380.503c, 380.523c,  
and 380.553c), as added by 2011 PA 277, and by adding section  
1311c.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 503c. (1) ~~Beginning with management agreements described~~  
2 ~~in this section that are entered into or renewed after the~~  
3 ~~effective date of this section, if~~ **If** the board of directors of a  
4 public school academy enters into or renews a management agreement  
5 with an educational management organization to carry out the  
6 operations of the public school academy, both of the following  
7 apply:

1           (a) The management agreement ~~shall require~~ **must include a**  
2 **requirement that** the educational management organization ~~to provide~~  
3 to the board of directors at least annually all of the same  
4 information that a school district is required to disclose under  
5 section 18(2) of the state school aid act of 1979, MCL 388.1618,  
6 for the most recent school fiscal year for which that information  
7 is available.

8           (b) Within 30 days after receiving the information under  
9 subdivision (a), the board of directors shall make all of the  
10 information it receives under subdivision (a) available through a  
11 link on the public school academy's website homepage, in a form and  
12 manner prescribed by the department.

13           **(2) In addition to the requirements under subsection (1),**  
14 **beginning with management agreements described in this section that**  
15 **are entered into or renewed after the effective date of the**  
16 **amendatory act that added this sentence, if the board of directors**  
17 **of a public school academy enters into or renews a management**

7 **discipline academy enters into or renews a management agreement**  
8 **with an educational management organization, all of the following**  
9 **apply:**

10 (a) The management agreement must include a requirement that  
11 the educational management organization provide to the board of  
12 directors at least annually all the same information that a school  
13 district is required to disclose under section 18(2) of the state  
14 school aid act of 1979, MCL 388.1618, for the most recent school  
15 fiscal year for which that information is available.

16 (b) The management agreement must include a requirement that  
17 the educational management organization provide to the board of  
18 directors, at least annually, financial statements for the  
19 educational management organization for the immediately preceding  
20 fiscal year that disclose the specific financial expenditures of  
21 the money received by the educational management organization under  
22 the management agreement, including expenditures made as a result  
23 of subcontracts. The financial statements must account for all  
24 funds retained as compensation by the educational management

5 (c) The management agreement must include a requirement that

8 educational management organization who is involved in the day-to-  
9 day operations and staffing at the strict discipline academy,  
10 including, but not limited to, the strict discipline academy's  
11 leadership team and teachers, whose compensation exceeds  
12 \$100,000.00 per year, a list providing a description and cost of  
13 each fringe benefit that is included in the individual's  
14 compensation package.

15 (d) Within 30 days after receiving the information under  
16 subdivisions (a), (b), and (c), the board of directors shall make  
17 all of the information it receives under subdivisions (a), (b), and  
18 (c) and the management agreement available through a link on the  
19 strict discipline academy's website homepage, in a form and manner  
20 prescribed by the department.

21 (2) As used in this section:

22 (a) "Educational management organization" means an entity that  
23 enters into a management agreement with a strict discipline  
24 academy.

25 (b) "Entity" means a partnership, nonprofit or business  
26 corporation, or any other association, corporation, trust, or other

29 comprehensive educational, administrative, management, or

1 instructional services or staff to a strict discipline academy.

2 (d) "School fiscal year" means the period that begins July 1  
3 and ends June 30.

4 Enacting section 1. This amendatory act takes effect 90 days  
5 after the date it is enacted into law.
