## INDIVIDUALS CARRYING PISTOL WHILE BOW HUNTING

## **SUMMARY:**

House Bill 4855 would amend section 43510 of the Natural Resources and Environmental Protection Act (NREPA) to provide that the act does not prohibit an individual who is hunting game with a bow and arrow from transporting a pistol or carrying a loaded pistol, regardless of whether the pistol is concealed or not, and regardless of whether the individual has a license to carry a concealed pistol or is exempt under state law from needing such a license.

Section 43510 now provides that NREPA, or a rule promulgated or order issued under NREPA by either the Department of Natural Resources (DNR) or the Natural Resources Commission (NRC), cannot be construed to prohibit an individual from transporting a pistol or carrying a loaded pistol, whether concealed or not, if the individual has a license to carry a concealed pistol or under the circumstances is otherwise allowed under other state law to carry a concealed pistol without obtaining such a license.

The bill would amend this provision to add that NREPA, or a rule or order issued under it, does not prohibit an individual from transporting a pistol or carrying a loaded pistol, whether concealed or not, if the individual is hunting game with a bow and arrow.<sup>1</sup>

## **FISCAL IMPACT:**

House Bill 4855 is unlikely to directly affect costs or revenues for the Natural Resources Commission nor the Department of Natural Resources. The FY 2025-26 NRC budget totals \$77,100 Gross (\$27,800 GF/GP) and the FY 2025-26 DNR budget totals \$543.2 million Gross (\$73.0 GF/GP). The bill is also unlikely to directly affect costs or revenues for local governments.
