SUMMARY:

House Bill 4861 would amend the Michigan Election Law to exclude nonpartisan candidates from a requirement that an affidavit of identity must indicate the candidate's party affiliation, or state that they do not have a party affiliation, for purposes of the applicable election.

The act requires candidates¹ to file an affidavit of identity when filing a nominating petition, qualifying petition, filing fee, or affidavit of candidacy, as applicable, or upon being nominated by a political party.

Among other information required to be included in an affidavit of identity, candidates must indicate their political party or, if they are running without political party affiliation, include a statement indicating that they have no political party affiliation.²

The bill would modify the above requirement so that it would apply only to candidates seeking nomination or election to a partisan office.

BRIEF DISCUSSION:

According to committee testimony, the provision requiring candidates who are not affiliated with a party to declare as much on their affidavit of identity has been a confusing challenge for candidates running in completely nonpartisan races since it was enacted in 2021. The legal right of several candidates in nonpartisan elections to appear on the ballot has been challenged on the basis that the candidates, evidently assuming that this provision applied only to partisan races, left this part of their affidavit blank. Courts have held that, in doing so, these candidates failed to meet the requirements of the above provision, which does not make a distinction between partisan and nonpartisan elections.³ Along the way, the courts have also noted that the current law is not entirely clear when it comes to candidates who are known from the start to have no political affiliation.⁴ For example, in concurring with a 2022 Michigan Supreme Court order denying an appeal in a case based

on this issue, Justice David Viviano wrote that "Statutory requirements for appearing on ballots must be followed, but those requirements should be clear and easy to understand... I strongly encourage the Legislature to correct this problem before the next election cvcle."5

Supporters of the bill argue that it would provide needed clarity for candidates filing affidavits of candidacy by no longer requiring those seeking a nonpartisan office to have to attest that they are doing so without a party affiliation.

BACKGROUND:

The forms used by candidates to file an affidavit of identity in 2020 and 2022 contained a blank line above the caption "political party, if a partisan office. if running without party affiliation list 'No Party Affiliation."

The forms were amended, by at least October 2023, to include clearer guidance for judicial and other nonpartisan candidates. The form now includes this checklist option for declaring a political party:⁸

Select one	- I am running for a partisan office, and my political party is:	
	- □ I am running for a partisan office, and my political party is: - □ I am running for a nonpartisan office without party affiliation (judicial office: see note above)	
	I am running for a partisan office without party affiliation.	

Judicial candidates are directed to use another form, which contains a single checkbox next to the statement "I am running for a nonpartisan office without party affiliation."

FISCAL IMPACT:

The bill would have no fiscal impact on the state or local units of government.
