

HOUSE BILL NO. 5294

November 13, 2025, Introduced by Reps. Maddock, Bollin and Lightner and referred to Committee on Economic Competitiveness.

A bill to amend 2000 PA 489, entitled
"Michigan trust fund act,"
by amending section 2 (MCL 12.252), as amended by 2023 PA 174; and
to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
- 2 (a) "Community district education trust fund" means the
- 3 community district education trust fund created in section 12.
- 4 (b) "Flint settlement trust fund" means the Flint settlement

1 trust fund created in section 11.

2 (c) "Local government reimbursement fund" means the local
3 government reimbursement fund created in section 3a.

4 (d) "Medicaid benefits trust fund" means the Michigan Medicaid
5 benefits trust fund established in section 5.

6 (e) "Medicaid program" means a program for medical assistance
7 established under title XIX of the social security act, 42 USC 1396
8 to ~~1396w-6~~. **1396w-8**.

9 (f) "Medicaid special financing payments" means the Medicaid
10 special adjustor payments each year authorized in the department of
11 health and human services appropriations act.

12 (g) "Michigan merit award trust fund" means the Michigan merit
13 award trust fund established in section 9.

14 (h) "Michigan opioid healing and recovery fund" means the
15 Michigan opioid healing and recovery fund created in section 3.

16 ~~(i) "Strategic outreach and attraction reserve fund" means the~~

19 (i) ~~(j)~~ "Tobacco settlement revenue" means money received by
20 this state that is attributable to the master settlement agreement
21 incorporated into a consent decree and final judgment entered into
22 on December 7, 1998 in *Kelly Ex Rel. Michigan v Philip Morris*
23 *Incorporated, et al.*, Ingham County Circuit Court, docket no. 96-
24 84281CZ, including any rights to receive money attributable to the
25 master settlement agreement that has been sold by this state.
