## **HOUSE BILL NO. 5295**

November 13, 2025, Introduced by Reps. Bollin and Lightner and referred to Committee on Economic Competitiveness.

A bill to amend 1921 PA 2, entitled

"An act to promote the efficiency of the government of the state, to create a state administrative board, to define the powers and duties thereof, to provide for the transfer to said board of powers and duties now vested by law in other boards, commissions, departments and officers of the state, and for the abolishing of certain of the boards, commissions, departments and offices, whose powers and duties are hereby transferred,"

by amending section 3 (MCL 17.3), as amended by 2021 PA 143.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 3. (1) The state administrative board shall exercise

- 1 general supervisory control over the functions and activities of
  2 all administrative departments, boards, commissioners, and officers
  3 of the this state, and of all state institutions.
- 4 (2) Except as provided in subsection (5), the state

  - (4) Except as provided in subsection (5), the state administrative board shall not have the power to transfer to any a state department, board, commission, officer, or institution any sum money from the an amount appropriated by the legislature for any other another purpose.
- 20 (5) Subject to subsection (6), the The state administrative 21 board may inter-transfer funds money within the appropriation for a particular department, board, commission, officer, or institution. 22 If the inter-transfer of funds could otherwise be accomplished 23 24 through the transfer process under section 393 of the management 25 and budget act, 1984 PA 431, MCL 18.1393, the state administrative 26 board may carry out the inter-transfer only if both of the following requirements have been met: 27
