HOUSE BILL NO. 5296

November 13, 2025, Introduced by Reps. Schriver, Bollin and Lightner and referred to Committee on Economic Competitiveness.

A bill to amend 1967 PA 281, entitled "Income tax act of 1967,"

by amending section 695 (MCL 206.695), as amended by 2025 PA 24.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 14 general fund.
- 15 (2) For 2024-2025 state fiscal year only, from the tax levied
- 16 under this part, the revenue collected under this part must be
- 17 deposited in the following manner:
- 18 (a) Up to \$1,200,000,000.00 to the general fund.
- 19 (b) After the deposit under subdivision (a), up to
- 20 \$50,000,000.00, if available, to the Michigan housing and community
- 21 development fund created in section 58a of the state housing
- 22 development authority act of 1966, 1966 PA 346, MCL 125.1458a.
- (c) After the deposits under subdivisions (a) and (b), up to
- 24 \$50,000,000.00, if available, to the revitalization and placemaking
- 25 fund created in section 696.
- 26 (d) After the deposits under subdivisions (a), (b), and (c),
- 27 up to \$250,000,000.00, if available, to the healthy Michigan fund
- 28 created in section 5953 of the public health code, 1978 PA 368, MCL
- **29** 333.5953.

- 1 (e) The balance of any revenue collected under this part after2 the deposits under subdivisions (a), (b), (c), and (d), to the
- 3 general fund.
- 4 (3) For the 2025-2026 state fiscal year only, from the tax
- 5 levied under this part, the revenue collected under this part must
- 6 be deposited in the following manner:
- 7 (a) Up to \$1,200,000,000.00 to the general fund.
- 8 (b) After the deposit under subdivision (a), up to
- 9 \$50,000,000.00, if available, to the Michigan housing and community
- 10 development fund created in section 58a of the state housing
- 11 development authority act of 1966, 1966 PA 346, MCL 125.1458a.
- 12 (c) After the deposits under subdivisions (a) and (b), up to

- 17 (6) For the 2028-2029 state fiscal year only, from the tax
- 18 levied under this part, the revenue collected under this part must
- 19 be deposited in the following manner:
- **20** (a) Up to \$1,200,000.00 to the general fund.
- 21 (b) After the deposit under subdivision (a), up to
- 22 \$50,000,000.00, if available, to the Michigan housing and community
- 23 development fund created in section 58a of the state housing
- 24 development authority act of 1966, 1966 PA 346, MCL 125.1458a.
- (c) After the deposits under subdivisions (a) and (b), up to
- 26 \$952,000,000.00, if available, to the neighborhood roads fund
- 27 created in section 13c of 1951 PA 51, MCL 247.663c.
- 28 (d) The balance of the revenue collected under this part after
- 29 the deposits under subdivisions (a) through (c) to the general

- 2 (7) Beginning with the 2029-2030 state fiscal year, from the
- 3 tax levied under this part, the revenue collected under this part
- 4 must be deposited in the following manner:
- 5 (a) Up to \$1,200,000,000.00 to the general fund.
- 6 (b) After the deposit under subdivision (a), up to
- 7 \$50,000,000.00, if available, to the Michigan housing and community
- 8 development fund created in section 58a of the state housing
- **9** development authority act of 1966, 1966 PA 346, MCL 125.1458a.
- 10 (c) After the deposits under subdivisions (a) and (b), up to
- 11 \$1,040,000,000.00, if available, to the neighborhood road roads
- 12 fund created in section 13c of 1951 PA 51, MCL 247.663c.
- 13 (d) The balance of the revenue collected under this part after
- 14 the deposits under subdivisions (a) through (c) to the general
