## HOUSE RESOLUTION NO. 196

Reps. Fox, Carra, DeSana, Smit, Rigas, Johnsen, Alexander, Markkanen, Martin, Cavitt, Maddock, Paquette, Pavlov, Fairbairn, Kelly, Hoadley, St. Germaine, Woolford, Outman, DeBoyer, Jenkins-Arno, Schriver and VanderWall offered the following resolution:

- 1 A resolution to demand that the Michigan Secretary of State
- 2 comply with the United States Department of Justice's request for
- 3 an unredacted copy of Michigan's computerized statewide voter
- 4 registration list, as required by section 303 of the Civil Rights
- 5 Act of 1960 and section 8(i)(1) of the National Voter Registration
- 6 Act of 1993, to the full extent permitted by law.
- 7 Whereas, The administration of voter registration for
- 8 elections for federal office is regulated, in part, at the federal
- 9 level; and
- 10 Whereas, The National Voter Registration Act of 1993 (NVRA)
- 11 was enacted to "protect the integrity of the electoral process" and

"ensure that accurate and current voter registration rolls are 1 maintained," and this purpose was furthered by the requirements of 2 the Help America Vote Act of 2002 (HAVA), which requires states to 3 conduct voter registration list maintenance "on a regular basis"; 4 and 5 6 Whereas, Federal law also imposes transparency requirements 7 related to voter registration. Under Title III of the Civil Rights Act of 1960, state election officers are required to retain and 8 preserve "all records and papers which come into [their] possession 9 10 relating to any application, registration, payment of poll tax, or 11 other act requisite to voting" in an election for federal office for a period of 22 months from the date of the election. Section 12 303 of the Civil Rights Act, 52 U.S.C. § 20703, further provides 13 that any such record "shall, upon demand in writing by the Attorney 14 15 General or his representative . . . be made available for inspection, reproduction, and copying at the principal office" of 16 the custodian of the record. Furthermore, section 8(i)(1) of the 17 NVRA, 52 U.S.C. § 20507(i)(1), requires each state to maintain for 18 19 at least two years and make available for public inspection "all 20 records concerning the implementation of programs and activities 21 conducted for the purpose of ensuring the accuracy and currency of official lists of eligible voters," with limited exceptions; and 22 23 Whereas, The Attorney General of the United States is entitled to certain state election records under these laws and has the 24 25 power to bring suit against the state to obtain them. Section 303 26 of the Civil Rights Act expressly requires records relating to 27 voter registration to be made available upon the demand of the Attorney General, and section 401 of the HAVA, 52 U.S.C. § 21111, 28 29 grants the Attorney General civil enforcement authority for that

act. Under the Supremacy Clause of the United States Constitution, 1 these federal requirements take precedence over state laws, even 2 when they conflict. Federal law authorizes the Attorney General to 3 bring a civil action against a state "to carry out the uniform and 4 nondiscriminatory election technology and administration 5 6 requirements" of the HAVA, including requirements to conduct voter 7 registration list maintenance in compliance with the NVRA; and 8 Whereas, On July 21, 2025, the Civil Rights Division of the 9 United States Department of Justice wrote a letter to Michigan 10 Secretary of State Jocelyn Benson to request "information regarding 11 the State's procedures for complying with the statewide voter registration list maintenance provisions of the [NVRA] and the 12 voter verification requirements of the [HAVA]." One specific piece 13 of information requested by the Department was "[t]he current 14 15 electronic copy of Michigan's computerized statewide voter 16 registration list." The United States Department of Justice sent an additional letter to Secretary Benson on August 14, describing the 17 Department's authority under the NVRA and the HAVA and further 18 requesting an unredacted copy of the statewide voter registration 19 20 list pursuant to Title III of the Civil Rights Act of 1960; and Whereas, On September 2, 2025, the Michigan Department of 21 22 State provided a partial response to the request of the United 23 States Department of Justice. However, the Michigan Department of State refused to provide an unredacted copy of the statewide voter 24 25 registration list, instead providing the United States Department of Justice with the public version of our statewide voter 26 27 registration list, the Qualified Voter File (QVF), citing the Michigan Election Law and Michigan's Freedom of Information Act and 28 29 disputing the United States Department of Justice's arguments about

privacy protections under federal law. The Michigan Department of 1 State reiterated that it would only be providing the public version 2 of the OVF in a further response to the United States Department of 3 Justice on September 9, 2025; and 4 Whereas, On September 25, 2025, the United States filed suit 5 6 against the Michigan Secretary of State, seeking an order 7 compelling the state to provide an unredacted copy of Michigan's 8 computerized statewide voter registration list. The federal 9 government has indicated that each registrant's date of birth and 10 their driver's license number or the last four digits of their 11 Social Security number are necessary for the Attorney General of the United States to determine whether Michigan is complying with 12 13 the voter registration list maintenance requirements of the NVRA 14 and the HAVA; and 15 Whereas, While the QVF does contain personal information, the United States Department of Justice has provided the Michigan 16 Department of State options for sharing this data in a secure 17 18 manner. The Department has indicated that the data "will be kept 19 securely and treated consistently with the Privacy Act" of 1974, 20 which provides strong safeguards against improper disclosure of information; and 21 Whereas, As the state's chief election officer, the Michigan 22 23 Secretary of State has a duty to administer and enforce Michigan election laws, including laws on voter registration list 24 25 maintenance. The United States Department of Justice and the Michigan Department of State thus share a common goal in ensuring 26 27 that elections held in Michigan are free and fair, which is facilitated by the careful review of voter registration records to 28

confirm they are as accurate and up to date as possible. Compliance

- 1 with federal law supports this shared goal; now, therefore, be it
- 2 Resolved by the House of Representatives, That we demand that
- 3 the Michigan Secretary of State comply with the United States
- 4 Department of Justice's request for an unredacted copy of
- 5 Michigan's computerized statewide voter registration list, as
- 6 required by section 303 of the Civil Rights Act of 1960 and section
- 7 8(i)(1) of the National Voter Registration Act of 1993, to the full
- 8 extent permitted by law; and be it further
- 9 Resolved, That copies of this resolution be transmitted to the
- 10 Michigan Secretary of State, the Attorney General of the United
- 11 States, and the clerk of each county, city, and township in
- 12 Michigan.
