SENATE RESOLUTION NO. 81

Senator Hertel offered the following resolution:

- 1 A resolution urging the Congress and the President of the
- 2 United States to permanently extend the Affordable Care Act
- 3 Enhanced Premium Tax Credit to help ensure that all individuals and
- 4 families have equitable access to healthcare.
- 5 Whereas, The Affordable Care Act (ACA), commonly known as
- 6 Obamacare due to its champion, former President Barack Obama,
- 7 established the Premium Tax Credit to make health insurance
- 8 coverage more affordable for individuals and families purchasing
- 9 insurance through the federal Health Insurance Marketplace; and
- 10 Whereas, The tax credit is based on income and household size,
- 11 ensuring that low- and middle-income Americans can access quality
- 12 healthcare coverage while capping the amount they must pay for
- 13 premiums as a percentage of their income. Approximately 21.8
- 14 million Americans benefit from the tax credit, including roughly

- 1 484,000 Michigan residents; and
- Whereas, In 2021, Congress passed the American Rescue Plan
- 3 Act, which expanded eligibility for the Premium Tax Credit and
- 4 enhanced credit amounts for tax years 2021 and 2022. These changes
- 5 were extended for three additional years, 2023 through 2025, under
- 6 the Inflation Reduction Act. The expansion of the Premium Tax
- 7 Credit under these acts significantly reduced health insurance
- 8 costs for millions of Americans, leading to record enrollment and
- 9 historic lows in the number of uninsured Americans; and
- 10 Whereas, Without the continuation of the Enhanced Premium Tax
- 11 Credit, millions of Americans could face steep cost increases,
- 12 risking a reversal of coverage gains and forcing many families to
- 13 forgo necessary healthcare due to unaffordability. A loss or
- 14 reduction of the credit would disproportionately harm working
- 15 families, seniors not yet eligible for Medicare, and vulnerable
- 16 individuals with chronic health conditions who depend on
- 17 consistent, affordable coverage at a time when Michigan families
- 18 are already struggling with paying for the increased cost of
- 19 essential goods and services; and
- 20 Whereas, Federal law prohibits the use of the Enhanced Premium
- 21 Tax Credit by non-citizens who are not lawfully present in the
- 22 United States; and
- 23 Whereas, Sustaining the Enhanced Premium Tax Credit is
- 24 essential to stabilizing the health insurance marketplace,
- 25 preventing sharp increases in uncompensated care costs, and
- 26 ensuring access to affordable healthcare for all Americans; now,
- 27 therefore, be it
- 28 Resolved by the Senate, That we urge the Congress and
- 29 President of the United States to permanently extend the ACA

- 1 Premium Tax Credit; and be it further
- 2 Resolved, That copies of this resolution be transmitted to the
- 3 President of the United States, the Secretary of the United States
- 4 Department of Health and Human Services, the President Pro Tempore
- 5 of the United States Senate, the Speaker of the United States House
- 6 of Representatives, and the members of the Michigan congressional
- 7 delegation.
