Act 174 of 1962

440.4205 Depository bank; item delivered by customer for collection.

Sec. 4205.

If a customer delivers an item to a depository bank for collection, then both of the following apply:

(a) The depository bank becomes a holder of the item at the time it receives the item for collection if the customer at the time of delivery was a holder of the item, whether or not the customer endorses the item, and, if the bank satisfies the other requirements of section 3302, it is a holder in due course.

(b) The depository bank warrants to collecting banks, the payor bank or other payor, and the drawer that the amount of the item was paid to the customer or deposited to the customer's account.
